WAIVER AND RELEASE OF LIABILITY

In consideration of Catahoula Recreation Club furnishing property to enable me to participate in ATV activities, I agree as follows:

I understand and acknowledge that: (1) risks and dangers exist in my use of ATV's and my participation in ATV activities; (2) my participation in such activities and / or use of such equipment may result in my injury, including but not limited to body injury, fractures, partial and / or total paralysis, eye injury, blindness, death, or other injuries that could result in serious disability; (3) these risks and dangers may arise from unforeseeable or foreseeable causes; and (4) by my participation in these activities I hereby assume all risks and dangers and all responsibility for any losses and / or damages, whether caused in whole or in part by the negligence or other conduct of myself, the owners, or employees of Catahoula Recreation Club, or by any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend, and indemnify Catahoula Recreation Club and it's owners, and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of ATV'S or my participation in ATV activities. I fully understand that I am releasing discharging and waiving any claims or action that I may have presently or in the future for the negligent acts or other conduct of my self, the owners, employees of Catahoula Recreation Club.

In signing this release, I hereby acknowledge, that I am responsible to investigate all terrain and trails that could spell disaster.

11. RIDE CAUTIOUSLY & OBEY ALL SIGNS
12. ALL BIKES MUST HAVE A FLAG
13. ALL RECREATION AT YOUR OWN RISK
14. EVERYONE MUST BE A MEMBER OF CATAHOULA RECREATION CLUB
15. WAIVER MUST BE SIGNED BEFORE ENTERING PROPERTY.
